## **Accommodations & meals:**

Four (4) nights in single rooms at **Conrad Dublin.** A member of the prestige luxury collection of the same name, located in the heart of Dublin's city centre, just opposite the National Concert Hall and just down the street from beautiful St. Stephens Green. Each room has an ergonomic workstation with broadband internet, data ports and international power connections, complemented by an array of modern guest services that include goose down duvets and oversized pillows,



spacious bathrooms with generous tubs, CD players and multi-channel televisions, dual-line telephones and voicemail. Alfie Byrnes, the hotel's extremely popular local pub, is a good choice for lunch or an evening libation.



Three (3) nights in classic single rooms at the **Bushmills Inn**, a charming former coach stop located in the village that is home to the world's oldest distillery. The public rooms of this cozy inn feature no less than four peat fireplaces and the bar is still lit by gaslight. While the rooms in the original inn are rather small, the newer rooms in the Millhouse addition are as spacious as they are well-appointed.

Three (3) nights in resort single rooms at the **Slieve Donard Hotel**, a grand Victoria edifice adjacent to Royal County Down Golf Club. Its spire is prominent in all the photographs of the famous ninth hole at RCD. Once a sad relic of a bygone ear, refurbishments at the Slieve have restored the impressive public rooms, provided several new bedrooms and added an excellent indoor pool and leisure centre.

## **Golf Courses:**

• Green fees for nine (9) rounds of golf as follows:

Island Golf Club. Island is a sturdy links course with a character which sharply contrasts that of the more tame dunes found at other Dublin area links courses. The original design was conceived by a group of wealthy Irishmen in the late 1800's, though today's course bears more the mark of Fred Hawtree and later Eddie Hackett. The course itself is a pleasant links surprise when tackling the links of Dublin; definitely worth a stop if in the area.



**Portmarnock Golf Club.** A most exclusive private club, Portmarnock is considered one of the "big four" in Ireland, and has hosted more Irish Opens than any other course. There are no weak holes here, but it is a subtle course. Portmarnock can go unappreciated the first time around, especially if there's no wind.



Royal Dublin Golf Club. A traditional out and back links layout whose greens are amongst the best in Ireland, Royal Dublin is the second oldest club in Ireland and the only "Royal" in the Republic. The present course was designed after WWI by famed English architect, Harry Colt, and revised by Fred Hawtree. Because the club's long time professional, Christy O'Connor, played in more Ryder Cups than any



other European, the clubhouse sports an interesting collection of Cup photographs and memorabilia.

**Portstewart Golf Club.** Portstewart is a challenging test that begins with an opening drive to a fairway some 75 feet below the tee. One of our members who rates courses for Golf Digest describes the setting for the opening nine as one of the most visually stunning in all of golf. (We think he liked it.)



**Dunluce Course at Royal Portrush Golf Club (Two Rounds).** This extremely demanding links course is the only course off

mainland Britain ever to host the Open Championship (1951). Barring the carnage at Carnoustie in 1999, Dunluce still boasts one of the highest winning scores in modern day Open history. Difficulty aside, the course is quite scenic and an enjoyable test of golf.





**Ardglass Golf Club.** The course begins with no less than six spectacular holes laid out atop the cliffs, directly over-looking the sea -- raw, rocky and dramatic. On the back nine, some spectacular holes are snuck in with tee boxes cantilevered out over the sea.

Royal County Down Golf Club (Two Rounds). Tucked artfully between the Mountains of Mourne and Dundrum Bay, playing Royal County Down can sometimes take second place to gazing at the scenery. Designed by Old Tom Morris for the princely sum of £4 in 1889, the course weaves through the rugged dunes along the shore in a totally natural fashion; simply put, this masterpiece is one of the best. And it is the highest rated course in Ireland.


