Your expedition package would include:

Golf Courses:

- Green fees for seven (7) rounds of golf as follows:

Club House Golf Club, Elie. The most apt description of Elie is unusual...in every way, in every sense. The links are old. Golfing records here indicate play on these grounds as early as 1589. No par fives; only two par threes; a submarine periscope to determine whether one is clear to hit a blind drive over the hill on the first hole. Lovely



views of Muirfield some 12 miles across the Firth of Forth. Fun, quirky, 19th century atmosphere. Well worth a visit.

The Balcomie Links of the Crail Golfing Society is a quirky Old Tom Morris design that hosts a club claiming to be 7th oldest golfing society in the world. The Links are true seaside links and provide excellent views of the North Sea. Crail is a must for golfers wishing to become immersed in the origins of the game.



Lundin Golf Club. Lundin was founded in 1868 and was played over what is known today as The Old Course, a composition of the seaward holes of both Lundin and Leven Links. In 1909, James Braid designed a new course from the original seaside holes and the area acquired away from the coast. A few modifications to the original layout have been made over the years although the character and splendour of Braid's original design is still very much in force. Lundin has hosted Open qualifying on many occasions, in addition to countless regional and national events.



Kingsbarns Golf Links (two rounds). Kingsbarns is a links course located about 7 miles southeast of St. Andrews on the road to Crail that opened in 2000 to rave reviews. In fact, the esteemed Golf Magazine rankings already place the course in the world's top 50. Splendid views of the North Sea and the Kingdom of Fife can be enjoyed from almost anywhere on the course. Definitely a championship course, Kingsbarns serves as one of the venues for the Dunhill Cup and it is anticipated that major tournaments will be held here in the future.



Panmure Golf Club. Despite its short length, the course demands so much accuracy that it is a fitting challenge even to world class golfers. When Panmure served as the final Open qualifier for Carnoustie in 2007, it was the 7th time the course was so honoured.



Carnoustie Golf Links. These gnarly, monstrous links are amongst the most challenging in championship play. Carnoustie was the site of Hogan's famed victory in the 1953 Open and, in 1999, the most bizarre collapse in modern Open history. (Never pair a French golfer with a French caddie!) A very stern test of golf, but a fair one indeed.

St. Andrews

Jubilee Course at St. Andrews. Named in honor of Queen Victoria's 75 years as Queen, Jubilee opened as a 12-hole golf course in 1897. The course has since been extensively reworked over the years with the largest re-design occurring in 1989 by Donald Steel who transformed the courses into a championship links that rivals its more historical brethren.



The cost for play on the Jubilee Course at St. Andrews is not included in the package. Ted Antonopoulos will acquire times directly from the Links Trust in St. Andrews. The cost will be £75 pp (\$115 pp based on an exchange rate of \$1.53).



Old Course at St. Andrews. Golf has been played here for half a millennium, and quirky and eccentric as it may be, the nervous thrill of playing away on the first hole, driving over the railroad shed on the diabolical 17th, or putting out of the Valley of Sin on the 18th green (with half the town looking on), is one of golf's great experiences.

The cost for play on the Old Course at St. Andrews is not included in the package. The group will Ballot for play on the Old Course and if successful will pay the greens fee on the day of play. The cost is £175 pp (\$268 pp based on an exchange rate of \$1.53).
