Golf Courses:

• Green fees for six (6) rounds of golf for the golfers as follows:



West Links of North Berwick. A day at one of golf's most historic venues, the West Links of North Berwick, is a truly unique experience. In fact, noted architect, Tom Doak, writes in *The Confidential Guide* that the West Links is one of his best 30 golfing experiences ever. The course

lies on the second oldest golfing ground in Scotland, features an ancient shepherd's wall as part of its design and is home to "Redan", the most copied par three ever. Old Tom Morris and his son, Tommy, were playing a match here in 1875 against the Parks when word came that Tommy's wife had taken ill during childbirth. They both died before he could return to St. Andrews. Tommy never recovered from their loss and died on Christmas Day of that year.

Gleneagles – Queens Course. Gleneagles Queens, like the Kings, was designed by James Braid following the First War. Somewhat shorter and less resistant to scoring, the Queens is as lovely as the Kings and a very enjoyable play if time permits.





Castle Stuart Golf Links. Castle Stuart was designed and developed by Mark Parsinen, one of the partners who opened widely acclaimed Kingsbarns in 2000. Parsinen's latest creation is situated on land which was given by Mary Queen of Scots to the Earl of Moray. Its tiered design sloping down to the water offers ocean views from every hole with the water or a local landmark directly in the line of play on 15 of them.

Royal Dornoch Golf Club. Royal Dornoch Golf Club, northernmost of the world's top twenty golf courses. Famed golf course architect, Donald Ross, was born in Dornoch and learned his trade on these links. Many of his favourite design features are found in this wonderfully natural golf course. Little wonder that, among Scottish courses, only St. Andrews and Muirfield are rated higher.



Castle Course at St. Andrews. Following the coastline east of St Andrews, The Castle Course is two miles from the town centre. St Andrews Links Trust is creating a seventh eighteen hole course to join its portfolio of six courses. The designer, David McLay Kidd, creator of Bandon Dunes on the West Coast of America, has created a typical Scottish golf experience. Each hole has a choice of five tees and the course will be playable between about 5300-7200 yards.



Old Course at St. Andrews. Golf has been played here for half a millennium, and quirky and eccentric as it may be, the nervous thrill of playing away on the first hole, driving over the railroad shed on the diabolical 17th, or putting out of the Valley of Sin on the 18th green (with half the town looking on), is one of golf's great experiences.



Touring Opportunities:

Edinburgh, Scotland's beautiful capital. Tour the Castle, the Royal Mile & Holyrood Palace—the British monarch's official residence in Scotland. There's even time to pop into an historic pub for lunch.





Dunrobin Castle & Gardens, the 189-room ancestral home of the Dukes of Sutherland. This is truly one of Scotland's great houses. High tea here is a must.

Spend a day trying to glimpse Nessie on **Loch Ness**, exploring **Cawdor Castle** where Macbeth slew Duncan and visiting **Culloden Battlefield** where the Scots finally lost to the English, an historic defeat that signaled the beginning of the Highland Clearances.



Distillery Tour. Learn the traditions of distilling and maturing Scotch whisky that have evolved through the centuries, using crafts passed from generation to generation in a continual process of refinement. Today fine malt whisky is produced in distilleries located in the most picturesque of settings, close to the natural ingredients on which their unique flavour depends.





Glamis Castle, a place of legends and fairytales. Family home of the Earls of Strathmore and Kinghorne and a royal residence since 1372. Childhood home of Her Majesty Queen Elizabeth The Queen Mother, birthplace of Her Royal Highness The Princess Margaret and legendary setting for Shakespeare's famous play 'Macbeth'.

Tour "auld grey toon", **St. Andrews.** Long before it became the Home of Golf, the town was the ecclesiastical centre of Scotland and home the Britain's third oldest university. Tour the castle, cathedral and university.


